**OWNER'S PERMISSION FOR RENTER  
TO APPLY FOR SERVICE**

In accordance with Texas Property Code § 92.008, I, the undersigned Property Owner, understand that it is required that I provide access to essential utilities for any tenants, including the ability to obtain water service. I do not desire to establish service to the property in my own name and subsequently obligate any tenants to assume responsibility for payment of services during his or her tenancy pursuant to a Renter's Service Application and Agreement. In the alternative, I grant authority to the below named Tenant/Applicant to establish service in his or her own name, as well authority for Tenant/Applicant to act and/or grant permission for all items contained in the East Central Special Utility District's Service Agreement as a requirement for such service.

I understand that electing to proceed in this manner will result in the complete termination of water service to the property upon request by the tenant, and there will be no service available for activities such as cleaning, lawn maintenance, etc. between tenancies unless I complete my own Service Application, establish my own Service Agreement, and pay any deposit required for such: **No Owner Deposit!**

The Texas legislature enacted a bill, effective September 1, 1993 allowing utility districts to give their customers the option of making the customer's address, telephone number, and social security number confidential.

WE MUST STILL PROVIDE THIS INFORMATION  
UNDER LAW TO CERTAIN PERSONS

We must still provide this information to (1) an official or employee of the state or a political subdivision of the state, or the federal government acting in an official capacity; (2) an employee of a utility acting in connection with the employees duties; (3) a consumer reporting agency; (4) a contractor or subcontractor approved by and providing services to the utility or the state, a political subdivision of the state, the federal government, or an agency of the state or federal government; (5) a person for whom the customer has contractually waived confidentiality for personal information; or (6) another entity that provides water, wastewater, sewer, gas, garbage, electricity, or drainage service for compensation.
